## Schedule of Dates and Fees, 2012 Camp Season

### Session One (One Week)

June 17 - June 23 . . . . . \$1,500

### Session Two (Two Weeks)

June 24 - July 7 . . . . . \$2,975

### Session Three (Two Weeks)

July 8 - July 21 . . . . . \$2,975

### Session Four (Two Weeks)

July 22 - August 4 . . . . . \$2,975

### Session Five (Two Weeks)

August 5 - August 18 . . . . . \$2,975

### Session Six (One Week)

August 19 - August 25 . . . . . \$1,500

Campers may combine sessions to extend their stay.

The camp fee is all-inclusive except for transportation to and from camp and personal items purchased. A \$50 store deposit will be added to your account for incidentals. Any account balance will be refunded or charged at the end of the session.

TRANSPORTATION: Most parents bring their children to and from camp. However, you may choose to have them fly. Information regarding airline transportation and the chartered bus to and from the Reno Airport will be sent at a later date and is available on our website.

**DEPOSIT FOR CAMP:** \$500 per camper, per enrolled session. This deposit will be charged upon acceptance. A \$500 deposit is also required for placement on our Waiting List. The Waiting List deposit is refundable if space does not become available or you turn down a space that is offered. Campers may not be enrolled and on the Waiting List at the same time. Enrolled Campers: Cancellation before 2/1 = No Service Charge. Cancellation after 2/1 and before 4/1 = \$250 Service Charge. Cancellation after 4/1 = No deposit refund (\$500 Service Charge). Cancellation after 4/10 = No refund of deposit or tuition balance. We recommend trip insurance to cover your expenses in the event you need to cancel.
